NOTICE: Failure to comply with your written promise to appear in Court as made on your citation will constitute a separate offense of Violate Promise to Appear and/or Failure to Appear which you may be charged and result in warrants being issued for your arrest. The issuance of arrest warrants will make you subject to entry into the wanted persons file and Failure to Appear in court may also result in the denial of renewal of your driver's license. **A PLEA MUST BE MADE IN WRITING OR IN PERSON ON OR BEFORE YOUR APPEARANCE DATE** (see reply and DSC request below). **JUVENILES 16 AND UNDER MUST CONTACT THE COURT FOR AN APPOINTMENT TO SEE THE JUDGE BY OR BEFORE YOUR APPEARANCE DATE. A PARENT OR GUARDIAN MUST APPEAR WITH THE JUVENILE.**

- I will provide a copy of a valid Texas driver's license or permit. (copy enclosed) If in the military you must execute and include an affidavit stating that you have not had DSC in another state in the past 12 months.
- I will provide a certified copy of my driving record (form provided by court)
- The alleged speed I was driving was not over 25 miles an hour over the posted speed limit.
- I have not completed a Driver's safety Course for dismissal of a ticket in the last 12 months.

NOTE TO COMMERCIAL DRIVER LICENSE HOLDERS: If you carry a CDL you are not eligible for Drivers Safety Course or Deferral for dismissal of a ticket regardless of vehicle class. A CDL has the words "Commercial Driver's License" written across the top. You can have a Class A which is not a CDL. Charges of Driving while License Suspended or Invalid, will NOT qualify for DSC)

PAYMENT OF DSC COURT COST/ADMIN FEE MUST BE PAID PRIOR TO JUDGE'S APPROVAL FOR DSC. I HAVE NOT RENDERED MY PLEA UNDER PAIN OR PENALTY OF PERJURY
