You do not need to. Call unless you still have questions after reading this. This form is furnished as a courtesy by the JUSTICE COURT, to assist you in the disposition of your ticket(s). To enter a plea of **NOT GUILTY**, indicate on the plea form (on the reverse side). This means you must appear before the court. You must contact the Judge for the hearing date. Mail the plea form and a copy of the citation to the Court.

A plea of **GUILTY** or **NOLO CONTENDERE**, (no contest), means you agree to waive appearance before the Court. Refer to the fine chart on the reverse side of this form for fine amount (court costs included). Return a copy of the citation, the plea form, and a

If you send a self-addressed stamped envelope, we will mail you a receipt.

If you fail to respond by the appearance date on your ticket, your fine is subject to change, and a charge of **VIOLATE PROMISE TO APPEAR** will be filed against you. The least you will be fined for this charge is \$300.00.

WARRANTS WILL BE ISSUED ON CHARGES IGNORED.

If you have a valid TEXAS driver's license, have not had a Defensive Driving Course to have a ticket dismissed in the last year, the speed was not 25 miles over the posted speed limit, and you have proof of insurance, you must contact the Judge by mail, prior to your appearance date about taking the Course. If you have a Commercial Driver's License, you are not eligible to take a Defensive Driving Course.

Court costs are \$102.10. Failure to respond by appearance date will result in the automatic suspension of the driver's license of residents of states belonging to the Non-Resident Violator Compact.
