You cannot resolve your ticket by telephone. CAUTION: Failure to appear or pay the fine on or before your appearance date indicated on your citation will result in issuance of additional **\$250 warrant** for your arrest and ***WILL RESULT IN DENIAL OF YOUR DRIVER'S LICENSE, PERMIT, AND/OR VEHICLE REGISTRATION.***

**IF YOU WISH TO ENTER A PLEA OF GUILTY OR NOLO CONTENDERE,** please indicate in the space below and refer to the schedule on the reverse side of this letter to determine the amount of fine(s) and costs assessed for the charge(s) against you. (The fine and cost are the same for Nolo Contendere and Guilty Plea): However, Nolo Contendere means that you do not contest the charge(s).

**PLEASE MAKE YOUR PAYMENT BY CASHIER'S CHECK OR MONEY ORDER,** to the Municipal Court indicated at the top of this letter and a copy of the citation with payment to assure credit.

If your case is heard by a judge and you are found guilty. The fine may be any amount that is authorized as the maximum set by law.

**ENCLOSE YOUR COPY OF CITATION TO INSURE PROPER CREDIT.**

1. I hereby enter a plea of **GUILTY/NOLO CONTENDER** (circle one) and waive appearance at trial. Money order or cashier's check in the amount of fine(s) is enclosed.
2. I hereby enter a plea of **NOT GUILTY** and request to be notified of next available trial docket date. I understand that I will make a personal appearance on that date. An appearance bond in the amount of \$250 for each charge filed against me is enclosed.
3. I hereby enter a plea of **NOT GUILTY** to my charge of **FAILURE TO MAINTAIN FINANCIAL RESPONSIBILITY.** Proof of insurance coverage obtained before my citation was issued, is enclosed.
