

INSTRUCTIONS FOR PAYING TRAFFIC CITATIONS

A traffic citation has been issued against you. If your charge is listed below, you may opt to plead guilty and pay the fine/court costs without having to appear in court. In that event, please sign the back of your citation and mail the full payment (*cashier's check/money order*) to **Headland Municipal Court**. If your charge is not listed below, please call the Magistrate at **(334) 693-2037** for further information.

IMPORTANT NOTICE

If you fail to appear in court on your assigned court date or if payment does not reach the Magistrate's office by your court date, your driver's license may be suspended and a warrant may be issued for your arrest. Additional costs will be incurred by you.

INSTRUCTIONS TO OBTAIN ACCIDENT INFORMATION

Since you have been involved in an accident, it is YOUR responsibility to obtain a copy of your accident report and a SR-13 form. A SR-13 form must be obtained, completed, and mailed to the State of Alabama within 30 days of your accident. These documents may be obtained from the Headland Police Department's Records Division located at 9 Park Street, Headland, Alabama by mail or in person. **There is a \$5 fee per copy.** If you plan to mail your request, please enclose a self-addressed stamped envelope. Checks or money orders should be made payable to **Headland Police Department** and sent to the address below. If you have any questions, you may contact the Headland Police Department Records Division at **(334) 693-2222**.
