You just received a traffic ticket and this document will explain your options

- Read this thoroughly
- Read both sides of your ticket
- Failure to comply with requirements of the traffic ticket may result in an arrest warrant, entry of a default judgment, MVD consequences, additional collection costs, and/or other penalties.

Your traffic ticket has check boxes to the right of each listed violation. You must appear in court on the appearance date if the Criminal box is marked for any violation. If only Civil boxes are marked, you have 3 options. You may need to choose more than one option if more than one violation is listed on the ticket.

Option 1: Attend a defensive driving class (DDS).

One moving violation may be dismissed. You can attend this class once every year (12 month period) for any eligible violation. You may attend class for only ONE violation even if there are multiple eligible violations listed on the ticket. You must pay a fine, appear in court, or request a hearing for additional violations. For more information on the schools call (888) 334-5565 or visit www.azdrive.com.

Drivers holding a Commercial Driver License and driving a privately owned vehicle may be eligible to attend DDS. Consult a legal professional if you have questions regarding how this could impact your CDL.

You may be eligible to attend defensive driving class if:

- You have not previously attended a defensive driving class in Arizona for a ticket issued within the last year:
- You have a valid driver license or state identification card;
- The violation did not involve an accident with serious injury or death;
- You are not requesting a hearing and are waiving your right to one.

Advantages of attending class for the violation:

- There is **no fine or conviction**.
- You do not need to appear in court.
- No points are placed on your driving record.
- Persons with a graduated license will not have to attend mandatory Traffic Survival School through MVD.
- Persons with a red-light violation of any kind will not have to attend mandatory Traffic Survival School through MVD.

Contact an accredited school within seven days of receiving your traffic ticket. The school will notify you within two business days if you are not eligible. You must complete the class at least seven days before the court appearance date written on the traffic ticket. The school will give you the cost of their course.

- is marked **Criminal Traffic**, or
- involved an accident with serious injury or death, or
- is not listed on the Fine/Sanction Schedule

Step 4. Mail this form and a copy of the ticket at least seven days prior to the court date listed on the front of the ticket. The court will mail you a civil traffic hearing notice that tells you when to appear in court for a hearing. If you do not receive a hearing notice within 30 days, please call (480) 488-1689.

Option 3: Request a Hearing.

Request a civil traffic hearing to contest the violation(s). You will have an opportunity to present evidence and have witnesses testify on your behalf. If you are found responsible, the fine(s) are due in full by 4:30 p.m. on the day of the hearing. Complete the following steps.

If you request a hearing, you will not be able to attend defensive driving school.

Step 1. Circle the corresponding letter (A-E) as it appears on the ticket: A B C D

Step 2. Read the following and sign: I enter a plea of not responsible and request a hearing for the violation(s) circled.

You must contact the court on or before the appearance date on your traffic ticket if your violation is not listed below or if your violation is for an accident resulting in serious injury or death. Excessive speeding in violation of 28-701.02A2 is a criminal offense and you must appear in court.

Si las cajillas marcadas indican que sus cargos son civiles, usted tiene tres (3) opciones. Si su boleto de infracción tiene más de un cargo listado, puede ser que usted necesite que elegir más de una opción.

Opción 1- Asistir a una clase de manejar defensivamente.

Si usted asiste a la escuela de manejar defensivamente, una (1) infracción de transito será descartada y no habrá puntos en su registro de conducir. Debe calificar a los requisitos de la escuela y pagar la cuota de registración el día que se lleve a cabo la clase. La escuela le dará el costa de la clase.

Opción 2- Pagar por teléfono, por correo o en línea.

Usted no tiene que comparecer al tribunal si usted elige renunciar su derecho a una audiencia, acepta declararse responsable y la multa(s).

Opción 3- Solicitud una audiencia.

INSURANCE VIOLATIONS

If you have proof of insurance for the date of violation on the vehicle listed on the complaint, you may mail in the proof to obtain a dismissal. In all other situations you must appear on or before the appearance date on your traffic ticket.

A conviction of ARS 28-4135 (No Proof of Insurance) requires a mandatory fine and suspension of your license and registration. If you produce to the Court proof of insurance in effect at the time of violation, the charge will be dismissed. If you did not have insurance on the date of violation, the mandatory fine may be reduced and the elimination of suspension may occur if (1) you do not have excessive prior convictions for no insurance (2) you provide the Court proof that you purchased a six-month insurance policy: and (3) you provide a copy of your driving record from the Motor Vehicle Department.
