

## Option One

### DEFENSIVE DRIVING CLASSES ARE OFFERED STATE-WIDE

#### You are eligible for the Defensive Driving Class if:

- You have **not** attended within the last 12 months (violation date to violation date); and
- You **do not** contest your ticket; and
- You were cited for a moving civil violation not involving serious injury or death; and
- If an asterisk (\*) is listed next to the violation on page 5.
- You do not have a commercial driver's license.

### DO NOT CALL THE COURT REGARDING REGISTRATION OR ATTENDANCE FOR DEFENSIVE DRIVING CLASS (DDC). SEE BELOW:

- If you choose to attend this course, you must complete the course at least seven days prior to the court arraignment date.** Your court date is located on your ticket. If you fail to attend a DDC before the court date, you are no longer eligible for defensive driving class.
- You may only register for an Arizona Supreme Court certified school for an in-person course or an online course, even if you live out of state. To register call **1-888-334-5565** or visit the website: **www.azdrive.com**
- Have your ticket with you when you schedule a class.
- Please locate the following information on your ticket before you call.
  - ✓ Driver's license number
  - ✓ Court Date
  - ✓ Complaint Number (located in the upper left hand corner of your ticket)
  - ✓ The section your violation appears in (A, B, C, D,E).
  - ✓ Violation Code
  - ✓ Violation Date
- Take your driver's license, traffic ticket and money order with you on the day of the class if you are attending in- person. Cash and personal checks **are not** accepted at the class. **\*\*Classes online are available and classes in-person are limited.**

## Option Three

### TO DENY THE OFFENSE OR PLEAD NOT GUILTY AND REQUEST A HEARING/TRIAL

The following statement must be read, signed and received before the court date shown on the bottom of your ticket. If your violation is marked criminal on your citation, you have the right to a trial vs. a hearing.

***I hereby request a Hearing, and give up the right to Attend a Defensive Driving Class.***

We must receive your request for a hearing **on or before the arraignment date**. You will then be notified by mail of your hearing date. **Setting a hearing will result in the loss of the privilege to attend defensive driving class for violation dismissal. Civil traffic violations will be set for a civil traffic hearing and criminal violations will be set for a pretrial.**

### **NOTICE TO JUVENILES+++**

1) Juveniles charged with civil traffic violation(s) only, may choose any option on page one. 2) Juveniles charged with criminal traffic violation or misdemeanor offenses must appear in court in person with a parent/guardian; 3) Juveniles who admit to, or are found responsible for, a moving traffic violation are subject to separate administrative action by the Motor Vehicle Division which may include attendance at traffic survival school (TSS) or suspension of driving privileges

**\*\* 28-2532A VEHICLE REGISTRATION:** (a) No fine if your registration was valid at the time of the ticket, show proof to the court; or (b) \$249.00 if renewed registration shown to court; or (c) \$720.00 if registration not renewed.

**\*\*\*\* 28-4135A-C VEHICLE INSURANCE:** (a) No fine with proof shown to court that your insurance was valid ON DATE AND TIME COMPLAINT WAS ISSUED; (b) \$227.00 with proof of six-months insurance with paid-in-full receipt and proof of no prior violations of 28-4135 within the past 24 months or no more than one violation within the past 36 months as evidence by the persons driving record shown to court on or before your court date. To obtain evidence of driving record from Arizona MVD, call (602) 255-0072. (c) \$1,085.00 and a **three-month suspension of driving privileges & vehicle registration** if no insurance shown.

**>>> 28-448 FAILURE TO CHANGE ADDRESS:** Fine may be reduced to \$140.00 with proof that the address has been changed with MVD.

**\*\*\* 28-3473** If your license is suspended for a reason other than failure to pay a civil traffic fine, you **must** appear and see the Judge on your court date. If it is suspended for failure to pay civil traffic violations **only**, you may pay the fine of \$137.00.

**\*\*\*\* 28-4139A SUSPENDED REGISTRATION PLATE:** (a) \$392.00 if reinstated vehicle registration and MVD receipt shown to court; or (b) \$641.00 if registration not reinstated; or (c) show proof from MVD to court if suspension is an MVD error.

**^^^ 28-924 to 28-931 AND 28-957 to 28-959.01 EQUIPMENT REPAIR:** Fines may be waived if proof of repair(s) is shown to the court.

**### 28-2153 FAILURE TO REGISTER VEHICLE:** Fine may be reduced to \$140.00 if proof of reinstated registration is provided to the court.

**# 28-3151 NO VALID DRIVERS LICENSE:** Fine may be waived if proof of reinstated license is provided to the court.

**+ 28-3169A, 28-2158 DRIVERS LICENSE OR VEHICLE REGISTRATION NOT IN POSSESSION:** (a) Charge will be dismissed with proof of driver license or registration valid ON DATE AND TIME COMPLAINT WAS ISSUED, (b) \$233.00 if no proof.

**++ 28-907A CHILD RESTRAINT SEAT ;** \$227.00 fine or if this is your First Offense, a diversion program may be available on this charge. Contact the court for details.

**+++TRAFFIC SURVIVAL SCHOOL NOTICE:** If you have been cited for 28-645A3A or are under 18 (First Offense) and are found responsible for a moving violation by the court, you will be required to attend a traffic survival school (TSS) class by the Motor Vehicle Division (MVD) pursuant to the requirements of the Arizona Revised Statutes. If you are eligible for Defensive Driving Class and complete the class, the violation will be dismissed and you will not be required to attend TSS by MVD.

## Information Card

### READ

**If you are charged with a traffic offense listed on pages 5 or 6, you have the following options:**

#### OPTION ONE

Attend a defensive driving class. If you qualify, the following information applies to **only one** eligible charge. When you complete the class, you do not have a fine to pay, you do not have to appear in Court and no points will be placed on your driving record. See instructions for attending defensive driving class on page 2.

#### OPTION TWO

Admit the offense(s) on the ticket in two different ways. (a) Follow the instructions for paying the fine on page 3; or (b) pay the fine in person at the court between 8:00am and 4:30pm Monday through Friday (excluding holidays). **WE DO NOT ACCEPT PERSONAL CHECKS.**

#### OPTION THREE

To deny the offense or plead not guilty and request a hearing/trial, follow the instructions on page 4.

#### NOTICE

If you fail to complete one of the three options above **on or before** the arraignment date listed on your citation, the court will enter a default judgment against you. A fine will be imposed, and your driver's license may be suspended until the original fine and late fees are paid to the court.

#### JUVENILES

See "NOTICE TO JUVENILES" on page 4 and "TRAFFIC SURVIVAL SCHOOL NOTICE" on page 5.

**"Proof" mentioned on page 6 must be provided to the court on or before the arraignment date listed on your citation.**

**DO NOT CALL THE COURT** unless the information you require is not listed herein. Please read page 1 and choose your option.

**FOR VIOLATIONS NOT LISTED, YOU MUST APPEAR IN PERSON FOR COURT.**
