# DEFENSIVE DRIVING CLASS (DDC) ARE OFFERED STATE-WIDE

## You are eligible for the Defensive Driving Class if:

- A. You have not attended within the last 12 months (violation date to violation date); and
- B. You do not contest your citation; and
- C. You were cited for a moving civil violation not involving serious injury or death; and
- D. If an asterisk (\*) is listed next to the violation on page5.

# INSTRUCTIONS FOR DEFENSIVE DRIVING CLASS (DDC)

- If you choose to attend this course, you must complete the course seven days prior to your Court date (located on your ticket just above your signature). If you fail to attend a DDC before the Court date you must contact the Court.
- You may register for an in-person course or an online course, even if you live out of the state, as long as it is certified by the AZ Supreme Court. To find a class call 1-888-334-5565 or visit the website: www.azdrive.com
- Have your ticket and a pen or pencil with you when you call to schedule a class. You will need to write down instructions for attendance as well as give important information from your citation to the person registering you.

  - ✓ Driver's license number
  - ✓ Court Date
  - ✓ Complaint Number (located in upper left-hand corner of your ticket)
  - ✓ The section your violation appears in (A, B, C, D, E).
  - ✓ Violation Code
  - ✓ Violation Date
- 5. Bring your <u>driver's license, traffic ticket and money order</u> with you on the day of the class if you are attending in person. Cash and personal checks <u>are not</u> accepted at the class. \*\*Classes online are available and classes in person are limited\*\*

\*\* **VEHICLE REGISTRATION:** (a) No fine if your registration was valid at the time of the citation, show proof to court; or (b) \$210.00 if renewed registration shown to court; or (c) \$667.00 if registration not renewed.

### \*\*\* SUSPENDED DRIVERS LICENSE

If you are charged with a violation of 28-3473A, you should contact MVD to find out how to reinstate your license. By following MVD's procedures, your sentence may be reduced. If you are charged with 28-3473A for failing to pay a fine, you should:

- 1) Contact MVD to determine which Court has your unpaid citations.
- 2) Pay citation in full.
- 3) Take proof of payments to MVD.
- 4) Pay reinstatement fee to MVD.
- 5) Bring proof of reinstatement to this Court on you court date.

The reinstatement of your license can significantly affect your sentence.

\*\*\*\* VEHICLE INSURANCE: (a) No fine w/ proof shown to court that the insurance was valid at the time of the citation; (b) \$210.00 if certificate of <a href="six-months">six-months</a> insurance and <a href="paid-in-full receipt">paid-in-full receipt</a> shown to court; or (c) \$1034.00 if no insurance shown and three month suspension of driving privileges & vehicle registration (d) if your insurance was expired, you must purchase six months of insurance AND go to MVD and obtain a record demonstrating that you have not had a prior no insurance conviction in the last two years and show this to court or your license and registration will be suspended by MVD.

\*\*\*\*\* SUSPENDED REGISTRATION PLATE: (a) \$372.00 if reinstated vehicle registration and MVD receipt shown to court; or (b) \$576.00 if registration not reinstated.

#### ++RED LIGHT VIOLATIONS

**IMPORTANT NOTICE**: If you have been cited for 28-645A3A, or are under age 18 (First Offense) and are found responsible for a moving violation by the court, you will be <u>required</u> to attend a traffic survival school (TSS) class by the Motor Vehicle Division (MVD) pursuant to the requirements of the Arizona Revised Statutes. If you are eligible for Defensive Driving Class and complete a class, the violation will be dismissed and you will not be subject to the requirement to attend a TSS class by MVD.

## **Pinetop Lakeside Justice Court**

If you are charged with a traffic offense listed on pages 5 or 6 you have the following options:

#### OPTION ONE

Attend a Defensive Driving Class. If you qualify, the following information applies to **only one** eligible charge. When you complete the course, you have no fine to pay, you do not have to appear in Court and no points will be placed on your driving record. See instructions for defensive driving classes on page 2.

#### **OPTION TWO**

Admit the offense(s) on the ticket in three different ways. (a) Follow the instructions for paying the fine on page 3; (b) pay the fine in person at the Court between 8:00am and 4:30pm Monday through Friday (excluding holidays); or (c) appear in Court on your Court date.

### **OPTION THREE**

To deny the offense or plead not guilty and request a hearing, follow the instructions on page 4.

#### NOTICE

If you fail to complete one of the three options above on or before the court date shown on the citation, the Court will enter a default judgment against you. A civil sanction will be imposed, and your driver's license may remain suspended until the civil sanction and late fees are paid to the Court. If you are charged with a criminal offense, and fail to appear, your license may be suspended and you may be arrested.
