

Option One

DEFENSIVE DRIVING CLASS (DDC)

You are eligible for the Defensive Driving Class if:

- A. You have not attended within the last two years (violation date to violation date); and
- B. You **do not** contest your ticket; and
- C. You were cited for a moving civil violation not involving serious injury or death; and
- D. If an asterisk (*) is listed next to the violation on page 5.

INSTRUCTIONS FOR ATTENDING DEFENSIVE DRIVING CLASS (DDC)

1. **If you choose to attend this course, you must:** Complete the class 10 days prior to your court date or call the court for an extension. Your court date is located on your ticket just ABOVE YOUR SIGNATURE. If you default (failure to appear at DDC before the court date) you are no longer eligible for defensive driving class.

3. **DO NOT call the Court.**
4. Have your ticket and a pen or pencil with you when you call to schedule a class. You will need to write down instructions for attendance as well as give important information on your ticket to the person registering you.
5. Please locate the following information on your ticket before you call.
 - ✓ Driver's license number
 - ✓ Court Date
 - ✓ Complaint Number (located in upper left hand corner of your ticket)
 - ✓ The section your violation appears in (A, B, C, D, E).
 - ✓ Violation Code
 - ✓ Violation Date
6. Bring your driver's license, traffic ticket and money order with you on the day of the class. Cash and personal checks **are not** accepted at the class.

6. Mail your payment, with this card, to the court. **PERSONAL CHECKS WILL NOT BE ACCEPTED.**

DO NOT SEND CASH. Make money orders payable to Pinetop Justice Court.

7. Payment in full must be **received or postmarked** on or before your court date, or extra fees must be added.
8. *If you are late in a civil traffic violation, a \$30 default fee and \$20 late fee must be added. If you fail to appear in a criminal or criminal traffic violation, a \$383 failure to appear fee and a \$20 late fee must be added.
9. **If you are unable to pay the amount in full, you must arrange a payment schedule prior to your court date: a \$20 payment schedule fee must be added.

** **VEHICLE REGISTRATION:** (a) No fine if your registration was valid at the time of the citation, show proof to court; or (b) \$200.00 if renewed registration shown to court; or (c) \$657.00 if registration not renewed.

***** SUSPENDED DRIVERS LICENSE**

If you are charged with a violation of 28-3473A, you should contact the Motor Vehicle Department to find out how to have you license reinstated. By following M.V.D.'s procedures, your sentence on 28-3473A may be reduced. If you are charged with 28-3473A for failing to pay a fine, you should:

- 1) Contact MVD to determine which Court has your unpaid complaints.
 - 2) Pay complaints in full.
 - 3) Take proof of payments to MVD.
 - 4) Pay reinstatement fee to MVD.
 - 5) Bring proof of reinstatement to this Court on you court date.
- The reinstatement of your license can significantly affect your sentence.

**** **VEHICLE INSURANCE:** (a) No fine if your insurance was valid at the time of the citation is shown to court; (b) \$200.00 if certificate of six-months insurance and paid-in-full receipt shown to court; or (c) \$1024.00 if no insurance shown and three month suspension of driving privileges & vehicle registration (d) if your insurance was expired, you must purchase six months of insurance AND go to MVD and obtain a record demonstrating that you have not had a prior no insurance conviction in the last two years and show this to court or you license and registration will be suspended by MVD. This may be done on-line at the MVD web site www.servicearizona.com.

***** **SUSPENDED REGISTRATION PLATE:** (a) \$362.00 if reinstated vehicle registration and MVD receipt shown to court; or (b) \$566.00 if registration not reinstated.

+ **DRIVERS LICENSE OR VEHICLE REGISTRATION NOT IN POSSESSION:**
 (a) Charge will be dismissed with proof of driver license valid ON DATE AND TIME COMPLAINT WAS ISSUED. (b) \$229.00 if no proof.

+++RED LIGHT VIOLATIONS

IMPORTANT NOTICE: If you have been cited for 28-645A3A, or are under age 18 (First Offense) and are found responsible for a moving violation by the court, you will be required to attend a traffic survival school (TSS) class by the Motor Vehicle Division (MVD) pursuant to the requirements of the Arizona Revised Statutes. If you are eligible for Defensive Driving Class and complete a class, the violation will be dismissed and you will not be subject to the requirement to attend a TSS class by MVD.

Please read page 1 and choose your option. **Do not** call the court unless the information you require is not listed herein.



Information & Bond Card

OPTION ONE

Attend a Defensive Driving Program. If you qualify, the following information applies to **only one** eligible charge. When you complete the course, you have no fine to pay, you do not have to appear in Court and no points will be placed on your driving record. See **Instructions for attending defensive driving class** on page two.

OPTION TWO

Admit the offense(s) on the ticket in three different ways. (a) Follow the INSTRUCTIONS FOR PAYING THE FINE BY MAIL on page 3; (b) pay the fine at the service counter of the Court between 8:00am and 4:30pm Monday through Friday; or (c) appear before the Judge to give an explanation on your court date. The Judge will see you any Tuesday at 10:00am.

OPTION THREE

Deny the offense on the ticket and request a hearing date in person or by mail. To deny the offense by mail, follow the instructions TO DENY THE OFFENSE AND REQUEST A HEARING on page 4.

NOTICE

If you fail to complete one of the three options above on or before the court date shown on a civil traffic ticket, the court will enter a default judgment against you. A civil sanction will be imposed, and your driver's license may remain suspended until the civil sanction and late fees are paid to the court. If you are charged with a criminal offense, and fail to appear, your license may be suspended and you may be arrested.
