

Option One

DEFENSIVE DRIVING CLASS (DDC) ARE OFFERED STATE-WIDE

You are eligible for the Defensive Driving Class if:

- You have not attended within the last 12 months (violation date to violation date); and
- You **do not** contest your citation; and
- You were cited for a moving civil violation not involving serious injury or death; and
- If an asterisk (*) is listed next to the violation on page 5.

INSTRUCTIONS FOR DEFENSIVE DRIVING CLASS (DDC)

- If you choose to attend this course, **you must complete the course seven days prior** to your Court date (located on your ticket just above your signature). If you fail to attend a DDC before the Court date you must contact the Court.
- You may register for an in-person course or an online course, even if you live out of the state, as long as it is certified by the AZ Supreme Court. To find a class call **1-888-334-5565** or visit the website: **www.azdrive.com**
- Have your ticket and a pen or pencil with you when you call to schedule a class. You will need to write down instructions for attendance as well as give important information from your citation to the person registering you.
- Please find the following information from your citation before you call:
 - ✓ Driver's license number
 - ✓ Court Date
 - ✓ Complaint Number (located in upper left-hand corner of your ticket)
 - ✓ The section your violation appears in (A, B, C, D, E).
 - ✓ Violation Code
 - ✓ Violation Date
- Bring your driver's license, traffic ticket and money order with you on the day of the class if you are attending in person. Cash and personal checks **are not** accepted at the class. ****Classes online are available and classes in person are limited****

- Mail your payment with this card to the court. **PERSONAL CHECKS WILL NOT BE ACCEPTED AND DO NOT SEND CASH.** Money orders are made payable to **Pinetop Lakeside Justice Court.**
- Payment in full must be **received or postmarked** before your court date, or extra fees must be added.
- If you are late in a civil traffic violation, a \$30 default fee and \$30 late fee must be added and additional FARE collection fees may be added later. If you fail to appear on a criminal or criminal traffic violation, a \$275 failure to appear fee and a \$30 late fee must be added.
- If you are unable to pay the full amount, you must arrange a payment schedule prior to your court date and a \$20 payment schedule fee must be added.

Option Three

TO DENY THE OFFENSE OR PLEAD NOT GUILTY AND REQUEST A HEARING

The following must be received on or before the Court date shown on the bottom of your citation.

NOTICE TO JUVENILES

1) Juveniles charged with civil traffic violation(s) only, may choose any option on page one. 2) Juveniles charged with criminal traffic violation or misdemeanor offenses must appear in court with a parent/guardian; 3) Juveniles who admit to, or are found responsible for, a moving traffic violation are subject to separate administrative action by the MVD which may include attendance at traffic survival school (TSS) or suspension of driving privileges.

**** VEHICLE REGISTRATION:** (a) No fine if your registration was valid at the time of the citation, show proof to court; or (b) \$183.00 if renewed registration shown to court; or (c) \$700.00 if registration not renewed.

***The court will reduce this fine to \$135 upon proof the animal has been properly licensed.

**** **VEHICLE INSURANCE:** A conviction of ARS 28-4135 requires a mandatory fine and suspension of your license and registration. If you show proof to the Court of insurance in effect at the time of the violation, the charge will be dismissed. If you did not have insurance on the date of violation, the mandatory fine may be reduced and the elimination of suspensions may occur if: 1) you do not have excessive prior convictions for no insurance, 2) you provide the Court proof that you purchased a six month insurance policy. This may be reduced to \$183.

***** SUSPENDED DRIVERS LICENSE**

If you are charged with a violation of 28-3473A, you should contact MVD to find out how to reinstated your license. By following MVD's procedures, your sentence may be reduced. If you are charged with 28-3473A for failing to pay fine, you should:

- 1) Contact MVD to determine which Court has your unpaid citations.
- 2) Pay citation in full.
- 3) Take proof of payments to MVD.
- 4) Pay reinstatement fee to MVD.
- 5) Bring proof of reinstatement to this Court on your Court date.

The reinstatement of your license can significantly affect your sentence.

***** **SUSPENDED REGISTRATION PLATE:** (a) \$361.00 if reinstated vehicle registration and MVD receipt shown to court; or (b) \$704.00 if registration not reinstated.

+DRIVERS LICENSE/VEHICLE REGISTRATION NOT IN POSSESSION:

(a) Charge will be dismissed with proof of VALID driver license on DATE and TIME ticket was issued. (b) \$293.00 if no proof.

++RED LIGHT VIOLATIONS

IMPORTANT NOTICE: If you have been cited for 28-645A3A, or are under age 18 (First Offense) and are found responsible for a moving violation by the court, you will be required to attend a traffic survival school (TSS) class by the Motor Vehicle Division (MVD) pursuant to the requirements of the Arizona Revised Statutes. If you are eligible for Defensive Driving Class and complete a class, the violation will be dismissed and you will not be subject to the requirement to attend a TSS

If you are charged with a traffic offense listed on pages 5 or 6 you have the following options:

OPTION ONE

Attend a Defensive Driving Class. If you qualify, the following information applies to **only one** eligible charge. When you complete the course, you have no fine to pay, you do not have to appear in Court and no points will be placed on your driving record. See instructions for defensive driving classes on page 2.

OPTION TWO

Admit the offense(s) on the ticket in three different ways. (a) Follow the instructions for paying the fine on page 3; (b) pay the fine in person at the Court between 8:00am and 4:30pm Monday through Friday (excluding holidays); or (c) appear in Court on your Court date.

OPTION THREE

To deny the offense or plead not guilty and request a hearing, follow the instructions on page 4.

NOTICE

If you fail to complete one of the three options above on or before the court date shown on the citation, the Court will enter a default judgment against you. A civil sanction will be imposed, and your driver's license may remain suspended until the civil sanction and late fees are paid to the Court. If you are charged with a criminal offense, and fail to appear, your license may be suspended and you may be arrested.
