Applications for Hardship must be picked up and completed at the court. You cannot request a hardship by mail or by phone.			
YOU MUST either appear at the court or pay your fines in full on or before the appearance date shown on your citation. If you fail to appear or pay in full, your driving privileges, the plates and registration on the vehicle will be suspended, and if the charges are criminal, a warrant for your arrest will issue and new charges may be filed against you. If you choose to pay by mail, you must complete Option 1 shown on the back of this information sheet. ALL PAYMENTS MUST BE MADE BY CASHIER'S CHECK OR MONEY ORDER payable to QUARTZSITE JUSTICE COURT, P.O. Box 580, Quartzsite, AZ 85346. The Court does not accept personal or company checks.
