Operating a motor vehicle with a suspended or revoked license  
Altered or no drivers license  
Fraudulent use of a driver's license  
Speeding in excess of 30 MPH over the speed limit  
Passing school bus while loading or unloading  
Any speed charge in school zone  
Note: Fines for speeding in a construction zone shall be increased by 50% and shall double in a residential zones

### APPEARANCE, PLEAS OF GUILTY AND WAIVER

I, the undersigned, do hereby enter my appearance on the offense charged on the other side of this summons. I have been informed and understand the charge(s) against me, and I am aware that I have the following rights:

- (a) To be represented by a lawyer;
- (b) To a speedy trial before a Judge;
- (c) To the presumption of innocence;
- (d) To subpoena witnesses on my behalf;
- (e) To be confronted with, and cross-examine, my accusers;
- (f) To refuse to testify at trial;
- (g) To have my case reviewed by some higher court, if convicted;

I am also aware that my signature to this plea of guilty will have the same force and effect as a judgment of court, and that this record will be sent to the appropriate Licensing Authority of this state (or to the state where I received my license to drive). I do hereby WAIVE my right to a trial by a Judge, and all my rights associated with a trial, and I do hereby PLEAD GUILTY to said offense as charged and agree to pay the penalty prescribed for my offense.
