Failure to Signal Turn	\$195.50 fine, \$29.50 costs, 2-year probation
Failure to Stop	\$195.50 fine, \$29.50 costs, 2-year probation
Fail to Yield to Emergency Vehicle	\$195.50 fine, \$29.50 costs, 2-year probation
Fail to Yield to Oncoming Traffic	\$75.50 fine, \$29.50 costs
Improper/No Turn Signal	\$ 75.50 fine. \$29.50 costs
Improper Lane Use	\$ 75.50 fine. \$29.50 costs
Improper U-Turn	\$ 75.50 fine. \$29.50 costs
Invalid License Plates	\$195.50 fine, \$29.50 costs, 2-year probation
Invalid Operator’s License (1 st & 2 nd offenses only)	\$195.50 fine, \$29.50 costs, 2-year probation
Left turn where Prohibited	\$150.50 fine, \$29.50
MIP of Alcohol (driving)	\$195.50 fine, \$29.50 costs; 2-year probation, attend/complete SATOP, LIFE and DIP within sixty (60) days
No Operator’s License	\$195.50 fine; \$29.50 costs. 2-year probation
No Proof of Insurance	\$195.50 fine; \$29.50 costs, 2-year probation
No Valid State Inspection	\$100.50 fine, \$29.50 costs
No Valid State License Plates	\$100.50 fine, \$29.50 costs
Open Container	\$195.50 fine, \$29.50 costs; 2-year probation, attend/ complete DAEP within sixty (60) days
Operating Motor Vehicle Where Prohibited	\$100.50 fine, \$29.50 costs
Parking Violation	\$ 50.50 fine, \$29.50 costs
Stop Sign/Signal Violation	\$100.50 fine, \$29.50 costs
Using License Plates of Another Person	\$175.50 fine, \$29.50 costs
Open Container Violation	\$150.50 fine, \$29.50 costs
Vision Reducing Material Exceeding 35%	\$195.50 fine, \$29.50 costs
Wrong Way on One-Way Street	\$100.50 fine, \$29.50 costs

NOTE: Any of the above fines may be increased up to \$500.00 and terms of probation may include one or more mandatory programs for any of the above charges, if:

- (a). There was an accident or injury; or
- (b). The violation involves the operation of a commercial motor vehicle.

Speeding

Up to 19 mph > limit and except	\$100.00 base fine + \$4.00 per mph > speed limit, \$29.50 costs, 2-year probation
More than 19 mph > speed limit	\$200.00 base fine + \$8.00 per mph > speed limit, \$29.50 costs, 2-year probation, attend/complete DIP within sixty (60) days
In a school or construction zone	\$350.00 base fine + \$8.00 per mph > speed limit, \$29.50 costs, 2-year probation, attend/complete DIP within sixty (60) days

No Safety Restraint

No Child Safety Restraint	\$25.00 fine, \$29.50 costs
No Seat Belt (adult)	\$10.00 fine (no court costs)

Traffic-Related Violations NOT subject to Section 479.350 RSMo. (Aug 28, 2016)

DWI/BAC (1 st offense)	\$500.00 fine, \$29.50 court costs and \$40.00 recoupment (8 points and "alcohol" offense) fee, sixty (60) days jail sentence SES; 2-year probation attend/complete SATOP, LIFE, DIP within sixty (60) days
C&I (with accident)	\$500.00 fine, \$29.50 costs, sixty (60) days jail time SES, 2-year probation, attend/complete DIP and LIFE within sixty (60) days, restitution to victim as ordered by the Court.
DWS/DWR	\$300.00 fine (1 st offense); \$500.00 fine (2 nd offense); (12 points) \$29.50 costs, sixty (60) days jail time SES; 2-year probation
Leaving Scene of Accident	\$500.00 fine; \$29.50 court costs, thirty (30) days jail (6 points) sentence SES, 2-year probation, attend/complete DIP within sixty (60) days, restitution to the victim as ordered by the Court.
Invalid Operator's License	\$500.00 fine; \$29.50 costs (3 rd offense only = 6 points)

NON-TRAFFIC ORDINANCE VIOLATIONS

NOTE: ALL of the following offenses may also include sixty (60) days jail time SES and 2-year probation

Assault	\$500.00 fine, \$29.50 costs, attend/complete Anger Management program within sixty (60) days
Assault on Law Enforcement	\$500.00 fine, \$29.50 costs, attend/complete Anger Management program within sixty (60) days
ATV Violation	\$175 fine, \$29.50 costs
Bad Check/Insufficient Funds	\$400.00 fine, \$29.50 costs, attend/complete MOP within sixty (60) days; restitution to victim

Curfew Violation	\$150 fine, \$29.50 costs
Destruction of Property	\$500.00 fine, \$29.50 costs, attend/complete Anger Management program within sixty (60) days
Discharging a Firearm	\$400 fine, \$29.50 costs, attend/complete MOP within Sixty (60) days
Disorderly Conduct	\$500.00 fine, \$29.50 costs, attend/complete Anger Management program within sixty (60) days
Dog(s)/Cat(s) at Large	\$100.00 fine (1 st offense); \$200.00 (2 nd offense); for 3 rd or more offense, up to \$500.00 fine \$29.50 costs
Endangering Welfare of Child	\$500.00 fine, \$29.50 costs; attend/complete MOP within sixty (60) days
Excessive Noise	\$100 fine, \$29.50 costs
Failure to Maintain CDL Log Book	\$300 fine, \$29.50 costs
Failure to Satisfy Judgment	\$50 fine, \$29.50 costs
Filing False Police Report	\$500 fine, \$29.50 costs; attend/complete MOP within sixty (60) days
Fireworks Violation	\$100 fine, \$29.50 costs
Harassment	\$500.00 fine, \$29.50 costs, attend/complete Anger Management program within sixty (60) days
Library Theft	\$250 fine, \$29.50 costs
Littering	\$200.00 fine, \$29.50 costs
MIP of Alcohol (non-driving)	\$300.00 fine (1 st offense); \$500.00 fine (2 nd offense); \$29.50 costs; attend/complete DAEP within sixty (60) days
MIP of Intoxicant	\$300 fine (1 st offense); \$500.00 fine (2 nd offense); \$29.50 costs; attend/complete DAEP within sixty (60) days
Misrepresentation of Age To Obtain Alcohol	\$300 fine (1 st offense); \$500.00 fine (2 nd offense); \$29.50 costs; attend/complete DAEP within sixty (60) days
No City Business License	\$150 fine, \$29.50 costs
Nuisance Violation	1 st offense: \$170.50 fine, \$29.50 costs (total = \$200.00) 2 nd offense: \$245.50 fine, \$29.50 costs (total = \$275.00) 3 rd offense: \$270.50 fine, \$29.50 costs (total = \$300.00) 4 th offense: \$370.50 fine, \$29.50 costs (total = \$400.00)

Involves physical assault	\$500.00 fine, \$29.50 costs, attend/complete Anger Management program within sixty (60) days
Petit Larceny	\$350 fine, \$29.50 costs, attend/complete MOP within Sixty (60) days
Phone Harassment	\$100 fine
Possession Controlled Substance (includes counterfeit substance)	\$500.00 fine, \$29.50 costs, attend/complete DAEP within sixty (60) days
Possession of Marijuana	\$500.00 fine, \$29.50 costs, attend/complete DAEP within sixty (60) days
Possession of Drug Paraphernalia	\$350.00 fine, \$29.50 costs; attend/complete DAEP within sixty (60) days
Possession of Narcotics	\$500.00 fine, \$29.50 costs, attend/complete DAEP within sixty (60) days
Possession of an Open Title	\$300.50 fine, \$29.50 costs
Providing Intoxicants to a Minor	\$300.00 fine, \$29.50 costs, attend/complete DAEP within sixty (60) days
Property Damage	Up to \$500.00 fine, \$29.50 costs; attend/complete MOP within sixty (60) days; restitution to victim
Public Intoxication	\$400.00 fine, \$29.50 costs, attend/complete DAEP within sixty (60) days
Resisting Arrest	
Non-Physical Resistance (includes flight)	\$400.00 fine, \$29.50 costs; attend/complete Anger Management Program within sixty (60) days
Physical Resistance	\$500.00 fine, \$29.50 costs; sixty (60) days jail time; SES fifty-five (55) days jail time; attend/complete Anger Management Program within sixty (60) days
Resisting Process	\$400 fine. \$29.50 costs
Failure to Obey Reasonable Request of Officer	\$300.00 fine, \$29.50 costs
Shoplifting (includes fraudulent return)	\$350.00 fine (1 st offense); \$500.00 (2 nd or more offense); \$29.50 costs; attend/complete MOP within sixty (60) days; restitution to victim (if property not recovered)
Skateboard Violation	\$ 75 fine, \$29.50 costs
Theft/Stealing	\$500.00 fine; \$29.50 costs; attend/complete MOP within sixty (60) days; restitution to victim
Trespass	\$250.00 fine (1 st offense); \$500.00 (2 nd or more offenses); \$29.50 costs; attend/complete MOP within sixty (60) days
