The offenses listed below DO NOT require a court appearance unless the Citing Officer has indicated such on your citation or to if you choose to plead Not Guilty and schedule a Trial. You may take care of the citation by doing one of the following **on or before** the stated court date located on the bottom of your citation:

1. Appear at the Clerk's office to sign a plea of guilty and waiver of trial and pay the fine for the charge by cash, check, money order or credit card.
2. Mail payment to address listed above. Also, make payable to: "South Bloomfield Mayor's Court" along with your ticket back to the court after signing the guilty plea and trial waiver on the bottom right hand side of ticket.
3. Go to the Court's website at [www.southbloomfieldpayments.com](http://www.southbloomfieldpayments.com) and follow the instructions to pay the citation on line. Paying the citation on line or by any means besides personal appearance is a guilty plea with a trial waiver whether the citation is signed or not.

If you did not provide **proof of insurance** at the time of the traffic violation, you must provide proof when making a payment in person or by mail.
