STATE REQUIREMENTS FOR MIP, DUI BY MINOR, AND CONSUMPTION VIOLATIONS; THE SUBJECT MUST HAVE THEIR LICENSE SUSPENDED, MUST TAKE COMMUNITY SERVICE, AND MUST TAKE AN ALCOHOL AWARENESS CLASS.

**DRIVING SAFETY COURSE - PLEA, AFFIDAVIT AND REQUEST
MUST HAVE POSTMARKED BY DUE DATE OF CITATION:**

I hereby enter my plea of GUILTY NO CONTEST to the offense, and request permission to take a DRIVING SAFETY COURSE.

Upon your request to take a DSC, you must furnish the Court with:

1. Copy of Ticket and a copy of valid Liability Insurance.
2. Must BE A **TEXAS RESIDENT WITH A VALID TEXAS DRIVER'S LICENSE** or a member of the United States military forces serving on active duty.
3. If this form is not **NOTARIZED**, swearing to #6 and #7, SDC Request WILL NOT be granted by the court.
4. Must send a **Money Order or Cashier's Check for \$114.10 ONLY**. NON-REFUNDABLE Court cost and Administrative fee.
5. **CANNOT** be going **25 MPH OR MORE OVER** the posted speed limit.

COMMERCIAL DRIVER'S LICENSE HOLDERS ARE NOT ELIGIBLE TO TAKE DSC.

6. I have not completed a Driving Safety Course within the last 12 months.
7. I am **not** in the process of taking a Driving Safety Course for another ticket in another court.
8. I understand I am responsible for completing a D.P.S. Approved Driving Safety Course or Motorcycle Operator Training Course and must remit the Certificate of Completion to the court within 90 days from the appearance date.
9. I understand if I am charged with an offense involving a Child Safety System the course to be completed **MUST** include four hours of Child Safety System Training. IDriveSafely.com
10. I understand that I must submit a copy of my driving record (Form 3A) available online at www.texasonline.com phone (512) 424-2600 or you may pick up an application at your local Texas Department of Public Safety office.

Sign sworn statement below a notary public that all facts are true and correct (a felony offense to make a false statement under oath).

I understand that I have 90 days from the appearance date to complete the Driving Safety Course and send the **ORIGINAL CERTIFICATE** issued after the completion of the course. The violation will then be dismissed.

I understand if I fail to comply and meet court dates I will pay the fine or additional charges will be filed against me.
