You have been issued a citation, which will be filed in the Justice of the Peace Court, Fayette County, Texas in the court that is circled above. PLEASE REVIEW YOUR OPTIONS ON THE REVERSE SIDE OF THE FORM BEFORE CONTACTING THE COURT.

You have the right to a trial. At the trial, you may, at that time, present your case to the court, with or without an attorney. Mail Form D on the reverse side of this page on or before your appearance date shown on the citation.

You may be eligible to receive Deferred Disposition. Contact the court for eligibility requirements. If you request Deferred Disposition, and it is granted, the citation will not appear on your driving record. Mail in Form B on the reverse side of this page on or before the appearance date shown on the citation. Do not make a payment until the court has approved your request.

You may be eligible to have this charge dismissed by successfully completing a Driving Safety Course or a Motorcycle Operator Training Course. You will lose that right if, on or before your appearance date, you do not provide the court with notice of your request to take the course. You are eligible to take a Driving Safety Course if you meet the following requirements: (1) You have a Texas Driver's License and you were NOT cited for 25 miles or more over the posted speed limit, and you were NOT driving 95 mph or more. (2) You have not taken a Driver's Safety Course in the last 12 months to dismiss a citation. (3) Remit payment in the amount of \$146.00 (4) Remit a copy of your auto liability insurance policy card. Mail in Form A on the reverse side of this page on or before the appearance date shown on the citation.

If you have a Commercial Driver's License you are NOT eligible for the Driving Safety Course or Deferred Disposition.
