DRIVING SAFETY COURSE OR A MOTORCYCLE OPERATOR TRAINING COURSE

- On or before your appearance date you enter a plea of NOLO CONTENDERE or GUILTY and present to the court, a request to take the course and send proof of Liability Insurance
- You must have a valid Texas Driver's License or permit. (send copy with your insurance)
- You must not have taken a course for dismissal of a traffic citation in the last 12 months prior to this citation and you submit a sworn affidavit to the effect (the proper form provided below)
- You were not charged with the offense of Speeding 25 MPH or more over the posted limit and 15 MPH or more for CMV drivers or charged with a violation of TDC Section 545.066, 545.401, 545.421, 550.022, 550.023, or a serious traffic violation as defined by Section 522.003
- You must send a \$112.10 Money Order ONLY made payable to the Justice of the Peace with the request and your Citation
- DRIVERS WHO HOLD A COMMERCIAL DRIVERS LICENSE ARE NOT ELIGIBLE.

NOTE: IF YOU ARE UNDER THE AGE OF 25 THE STATE REQUIRES YOU TO TAKE THE DRIVING COURSE UNLESS YOU CHOOSE TO ENTER A PLEA OF NOLO OR GUILTY AND PAY THE FINE.
