If you have a Texas Drivers License and have been charged with a moving violation, you may request that this charge be dismissed by successfully completing a Driving Safety Course or Motorcycle Operator Training Course, which ever is applicable, that is approved by the Department of Public Safety, If you do not have a commercial drivers license, you have not exceeded the speed by more than 24 MPH, or you have not taken a Driving safety/motorcycle training course within the last 12 months of the citation. You will lose this right if you do not provide the court notice of your request to take the course, on or before the appearance date located at the bottom of the ticket.the following requirements must be received by this office;:1/\$109.10 administrative fee,2/proof of auto liability insurance on the vehicle you were driving at the time the citation was issued. 3/ a copy of your drivers license and 4/request a driving history from the state (forms are available in our office) the course must be completed and driving history received within 90 days of the citation date, it is your responsibility to make arrangement to take the course. Failure to comply with these terms will result in further actions being taken.
