 If you do not respond or appear for court hearings:

The court will find that you committed the infraction. You may lose your driver's license privilege. Your penalty will be increased. The state must prove by a preponderance of the evidence that I committed the infraction. I know I can require (subpoena) witnesses, including the officer who wrote the ticket to attend the hearing. The court will tell me how to request a witness's appearance. I understand this will go on my driving record if I lose and "traffic" is checked.
