Note: If you have been cited for a red light violation and are found responsible for the violation by the court (either by pleading responsible or by challenging the ticket at a hearing and losing), you will be required to attend a Traffic Survival School (TSS) class by the Motor Vehicle Division (MVD). (TSS is a separate class from Defensive Driving School). If however, you are eligible for Defensive Driving School and complete the class, the violation will be dismissed and you will not be subject to the MVD requirement to attend a TSS class.

28-701.02 (Excessive Speed) (Criminal - Appear in court unless DDS eligible)	
If you are otherwise eligible for Defensive Driving School and your speed was no more than 24 miles per hour over the speed limit the judge will allow you to attend defensive driving school for dismissal of a 28-701.02 charge. If you were doing 25 mph over the speed limit or higher you are not eligible for DDS.	
28-702.01A (Waste of Finite Resources) (56 to 65 in a 55 zone) . . . . .	\$103
No points on license. Also an insurance company may not consider a Waste of Finite Resources citation as a moving traffic violation.	
28-702.01C (More than 65 mph in a 55 mph zone) . . . . .	See 28-701A chart above

If 1 <sup>st</sup> offense the Court may suspend the fine if you prove to the court that you have now repaired or installed an adequate muffler.	
28-959.01B (Window tint violation) . . . . .	\$137
28-2153A or 28-2532 (Registration violation) . . . . .	\$671
If you had valid registration at the time you received the ticket but couldn't show it to the officer you may have the violation dismissed if you show proof to the court <u>by your court date</u> .	
If you didn't have valid registration at the time of the ticket, but have subsequently registered the vehicle, you may have the fine amount reduced to \$192 if you bring proof of registration to the court.	
28-3151 (Driving without a valid or properly endorsed license) . . . . .	\$192
28-3169 (Driving without license in possession) . . . . .	\$192
This charge may be dismissed if the Defendant shows the court proof that they had a driver's license that was valid at the time of the violation.	
28-3473 (Driving on a Suspended License) Criminal - must appear in court.	
If the only reason your license is suspended is because a court suspended your license for not paying a fine (pursuant to 28-1601), you may be able to have this violation dismissed if you get your license reinstated and bring proof to the court.	
28-3482 (Driving on a Suspended License) Civil . . . . .	\$315
28-4135 A, B, or C (No proof of insurance) . . . . .	\$1027
If 2 <sup>nd</sup> within 36 months . . \$1472 If 3 <sup>rd</sup> within 36 months . . \$1917	
If you had valid insurance at the time you received the ticket but couldn't show it to the officer - you may have the violation dismissed if you show proof to the court ( <u>by your court date</u> ). If you did not have insurance at citation time but then prove to the court that A) you have now acquired a 6 month or longer policy, and B) you bring the court a copy of your MVD driving record that proves that you have not been found responsible for a violation of 28-4135 in the past 24 months or not more than one violation within the past 36 months, you may have the fine reduced to \$137	
28-4139A (License plate violation) . . . . .	\$582

The above figures include the Base Fines to which are added several state and county mandated surcharges: a \$20 Graham County Fee, a \$10 Court Security Fee, a 78% surcharge, a \$20 probation assessment, a \$13 additional assessment, a \$9 Victim Rights surcharge, a \$2 Victim Rights Enforcement surcharge, a \$4 Peace Officer Training assessment.
